**Public Notice:  
PNPD/CAPES Scholarship in the PPGH/UDESC  
(Edital DG. 010/2015)**

1 - The Postgraduate Program in History of the State University of Santa Catarina (UDESC) is accepting, **until 19th of June, 2015** applications for one (01) post-doctoral scholarship sponsored by the Brazilian Program PNPd/CAPES ("Programa Nacional de Pós-Doutorado/CAPES"). The selected candidate will receive a monthly scholarship of R\$ 4.100,00 (four thousand and a hundred Brazilian Reais).

2 - The PNPd/CAPES finances postdoctoral stages in academic postgraduate programs (*stricto sensu*) recommended by the CAPES and its main objectives are: to promote high level studies; to strengthen national research groups; to renew the staff of the postgraduate programs in the national institutes of higher education and research; to promote the insertion of Brazilian and foreign researchers at a post-doctoral level, stimulating the integration with research projects developed in postgraduate programs in Brazil.

3 - The scholarship holder selected by the Postgraduate Program in History will have to:

3.1 - dedicate 40 weekly hours to the post-doctoral stage;

3.2 - develop activities in one of the laboratories linked to the Program, taking part in study groups and other activities promoted by it;

3.3 - develop teaching activities (giving lectures, workshops, seminars and if need be disciplines in graduate course);

3.4 - develop research activities (with a particular project related to the concentration area of the Program, that is to say, Present Time History, being necessarily consistent with one of research lines: Political Cultures and Sociabilities" or "Languages and Identifications");

3.5 - Take part in periodical meetings (every two weeks at least), with the supervisor of his/her post-doctoral stage, in the Program, so that the supervisor can follow the activities that will be developed.

3.6 - Hand a detailed report of his/her activities, in the last month of the stage, to the Coordination of the Program.

3.7 - If the scholarship holder wishes, he/she can act as advisor of graduate and postgraduate (master and doctorate) dissertations, as well as take part in dissertation pre-defense and/or defense.

4 - To apply to PNPd/CAPES scholarship in the PPGH/UDESC, the candidate needs to have PhD (doctorate) in History or in similar fields and, at the moment of the candidature, must be in one of the following situations:

a) Brazilians or foreigners living in Brazil who hold a temporary visa, without formal employment;

b) Foreigners not living in Brazil, without employment;

c) Professors or researchers living in Brazil with employment in higher education institutions or public institutions of research. In this case, candidates with employment in UDESC are not eligible.

The scholarship will last for twelve (12) months.

§ 1.- The extension or renewal of the scholarship, at the discretion of PPGH and based on the manifest interest of the candidate, is possible for the approved candidate who is Brazilian or who lives in Brazil and has a temporary visa, without employment, or who, at the moment of the selection, is foreigner not living in Brazil, without employment.

§ 2. - In the case of the candidate who is professor or researcher in Brazil with employment in higher education institutions or public institutions of research, the scholarship will not be renewed after 12 (twelve) months.

6 - The candidate to the scholarship has to fill in the registration form (*ficha de inscrição*) available on the opening page of the electronic site of the PPGH-UDESC ([www.ppgh.udesc.br](http://www.ppgh.udesc.br) or [www.faed.udesc.br/ppgh](http://www.faed.udesc.br/ppgh)), as well as to send, to the e-mail of the PPGH-UDESC ([ppgh.udesc@gmail.com](mailto:ppgh.udesc@gmail.com)), until June 19, 2015, a digital copy (in file "pdf") of the following documents:

6.1. Diploma certifying title of Doctor, obtained in courses evaluated by CAPES and recognized by the Conselho Nacional de Educação/MEC. In case of diplomas obtained in foreign institutions, they will be subject to analysis of the PPGH-UDESC;

6.2. Updated CV (May or June 2015) on the CNPq Lattes Platform or, if foreign, CV indicating the publication of scientific works of impact and/or academic merit awards, according to Anexo III of the Portaria n. 086/2013 of the PNPd/CAPES, also duly proven;

6.3. Statement or document proving that the candidate is not retired or in a similar position;

6.4. If foreign not living in Brazil, proof of residential address abroad at the moment of the application submission;

6.5. If professor or researcher in Brazil with employment in higher education institution or public research institution, document evidencing the home institution leave for a period compatible with the duration of the scholarship;

6.6. Work plan to be developed as a post-doctoral stage, which has to include:

6.6.1. Indication of Laboratory(ies) linked to the Program in which the candidate prefers to take part with justification of choice;

6.6.2. - Indication of topics that could be developed in lectures, workshops and seminars to teach in post-doctoral stage;

6.6.3 - Indication of research activities (the candidate must attach an individual project related to the concentration area of the Program, namely Present Time History, necessarily consistent with one of its two lines of research, "Political Cultures and Sociabilities" or "Languages and Identifications");

6.6.4 - Indication of themes and research problems that could count on his/her possible co-supervision;

6.6.5 - Indication, where applicable, of other activities that could be developed, consistent with the guidelines of the PPGH-UDESC;

6.6.6 - Schedule with all proposed activities.

7 - The evaluation of candidates will be done by a committee of three (3) professors and one (1) student in the PPGH.

7.1. Applications that have not submitted all the required documents (specified in item 6), or whose candidates are not complying with the requirements of PNPd / CAPES will not be accepted.

7.2. The list of the accepted submissions will be published on **June 23, 2015**.

7.3. The candidates whose submissions are accepted will participate in the defense session of the work plan. The work plans will be evaluated by the selection committee on June 29, 2015, in schedules previously informed on the homepage of the electronic site of PPGH (< [www.ppgh.udesc.br](http://www.ppgh.udesc.br)> or <[www.faed.udesc.br/ppgh](http://www.faed.udesc.br/ppgh)>).

7.3.1. The defense may be conducted in person or virtually (online);

7.3.2. Virtual defense may be made if the candidate does not reside in Florianópolis or in the metropolitan area, and only if this option is indicated on the registration form (*ficha de inscrição*), instructions in this regard being made available on the home page of the electronic site of the PPGH (in Portuguese).

7.4. In the evaluation of the candidates, the selection committee will consider:

7.4.1. The relevance, consistency and feasibility of the work plan provided by the candidate, with reference to the PNPD profile, concentration area of the PPGH, and at least one of the research lines of the Program;

7.4.2. The academic trajectory, based on the CV presented considering, in particular, the experience in teaching, research and supervision;

7.4.3. The performance in defending the work plan.

7.5. The final results of the selection will be published on the homepage of electronic site of the PPGH, on July 1, 2015, from 6 pm.

8 - The approved candidate should be prepared to start his/her activities in the Program from September 1, 2015.

9- The approved candidate will be subject to the rules of the PNPD/CAPES (see: <<http://www.capes.gov.br/bolsas/bolsas-no-pais/pnpd-capes>>) as well as to the rules in the UDESC which govern post-doctoral stages.
